

2010 Funny video camping Montescudaio Contest rules

1. Camping Village Montescudaio, is organizing on its site www.camping-montescudaio.it in collaboration with www.fototoscana.it, the “ 2010 Funny video Camping Montescudaio Contest “
2. Only the videos with the following features will be viewed:
 - **Vacations at Camping Montescudaio**Video restrictions: the videos must be appropriate for the publishing on a site open to public access. Obscenities, provocative or other offensive content won't be taken into consideration. The definition of “ appropriate content “ is at the Camping Village Montescudaio's discretion.
3. The videos must be uploaded on www.youtube.com, and must necessarily have “ Camping Montescudaio “ in the title.
4. Of all the videos received , 3 of those judged amongst the funniest will be prized with the following:
 - a) **FIRST PRIZE:** a free stay of one week in a Caravancasa Family or Superfamily, or two weeks in the camping with tent/caravan belonging to the client, for 4 pax on any period that does **NOT** fall between 10/07/11 and 10/08/11 .
 - b) **SECOND PRIZE.** A 50% discounted stay of a week in Caravancasa Family or Superfamily or two weeks in the camping with tent/caravan belonging to the client, for 4 pax , on any period that does **NOT** fall between 10/07/11 and 10/08/11 .
 - c) **THIRD PRIZE .** A basket filled with typical products of Tuscany and D.O.C Montescudaio wine, to be collected at Camping Village Montescudaio during the 2011 season.
5. The next 6 funniest and most representative videos will also be selected and highlighted.
6. The presentation of the works must be made within 15/10/10. The author must agree to keep the video posted on www.youtube.com at least until march 2011.
7. The presentation date can be postponed due to eventual circumstances that go beyond the organizer's control. Any extension of the expiry date will be published on the www.camping-montescudaio.it site.
8. The participation can take place only through this channel and **not** by posting directly to the Camping Village Montescudaio addresses.
9. Only the videos for which the following subscription attachment has been sent , will be able to participate in the “ 2010 Funny video Camping Montescudaio Contest “. The subscription must be sent to the following address video@camping-montescudaio.it and must include the youtube link where the video is uploaded.
10. The contest is **Completely FREE** and is restricted to people of over 18 years of age . It is open to anyone with exception of the organizers, the Camping Village Montescudaio employees and their next of kin . By next of kin we intend spouses, parents and children.
11. Every participant can submit a maximum of 3 pieces and must display the title, date and place of recording for each.
12. Every author must hold all the rights of the video posted on www.youtube.com, and must therefore dismiss the www.camping-montescudaio.it site from any responsibility including the request for pain and suffering and exemplary damages .
13. It is implied that the uploading of videos on www.youtube.com on behalf of the participant to the 2010 Funny Video Contest requires the author to have full possession of the copyright of the video itself.
14. According to the above statements , the www.camping-montescudaio.it site cannot therefore be held responsible for the rights of use and paternity of the images or any other content connected to the 2010 Funny Video Contest images.
15. Camping Village Montescudaio will email all its clients , the list of winners ,within 15/10/10 , highlighting the links of the 3 winning videos and the other 6 most representative ones. It will then contact the winners of the contest , to make agreements for the prizes. The names and photos (if sent by the authors) of the first 3 winners will be displayed on our site.
16. The jury will be made by the professional Staff of www.fototoscana.it, together with the Management

of the Camping Village Montescudaio. Their judgement will be final.

17. All the videos uploaded to www.youtube.com can be used **free of charge** by Camping Village Montescudaio and by www.fototoscana.it, organizers of the 2010 Funny Video Contest, for their own initiative . By no means will they be released to third parties.
18. The personal data necessary to the compilation of the Registration Module will be managed according to the Italian privacy laws.
19. The participation to the 2010 Funny Video Contest implies the full acknowledgement of the present regulation
